## WHO ARE WE

The Mississippi Center for Legal Services Corporation (MCLSC) is a non-profit law firm funded by the Legal Services Corporation in Washington D.C. We provide free civil legal aid mostly to low-income eligible people living in Covington, Forrest, Greene, Jefferson Davis, Lamar, Marion, Jasper, Jones, Smith, Wayne, Perry, Clarke, Kemper, Lauderdale, Leake, Newton, Neshoba, Noxubee, Scott, Hinds, Copiah, Holmes, Madison, Rankin, Simpson, Warren, Yazoo, Amite, Lawrence, Lincoln, Franklin, Pike, Walthall, Adams, Claiborne, Jefferson, Wilkinson, Hancock, Harrison, Pearl River, Stone, George and Jackson Counties.



## ELIGIBILITY

Persons seeking assistance should call 1-800-498-1804. Eligibility is based on total household income and the number of people living in the home. Income includes things like wages and salary before any deductions are taken out and

regular payments from other such as Social Security, SSI, TANF. We do not charge an attorney fee for the services we provide. You may be asked to pay court filing fee(s) that are required to file your case in court.

## TYPES OF CASES

We handle cases that help support the family, help to preserve the home, help maintain the family's economic stability and help maintain the safety, stability, and health of the family. This includes, but is not limited to, cases such as bankruptcy, collection defense, education issues, employment and unemployment issues, eviction defense, foreclosure defense, protection from domestic violence and sexual assault, deeds, elder abuse, divorce, adoption, custody, guardianship, expungement of certain criminal records, emancipation, neglect and abuse, healthcare issues, Social Security, SSI, Last Will, and Power of Attorney.

MCLSC does not accept any cases or matters prohibited by the Legal Services Corporation Act, such as Redistricting, Abortion Rights, Class Actions, Representation of Prisoners, Workers Compensation, Criminal Cases, Euthanasia or Personal Injury.

The list of cases accepted or not accepted does not include every case type. When you contact us for assistance, you will be screened to determine if we will accept your case or not.

## COMMUNITY EDUCATION

MCLSC will provide someone to speak to any group, church or organization about the services we provide or about a certain legal topic. Requests should be submitted to the Executive Director in the Hattiesburg office, or the Deputy Director in the Jackson office, or to the Managing Attorney for the office providing the services to your location.
